Cookie Policy

The company under the name "PRIVATE CLINIC GEORGIADIS-CASPEDES CLINIC ATHENS" with headquarters in the Municipality of Athens (24 Drosopoulou St., Postal Code 11257) ("We") uses cookies to facilitate your navigation on its website (the "Website"), improve the functioning of the Website in general, and present content that reflects your interests. This Policy aims to provide you with clear and comprehensive information about what cookies are, what types of cookies we use, and how you can enable or disable their use.

1. What is a cookie?

Cookies are small text files containing information that are sent from a website to the internet browser system you are using, stored on your computer, and retrieved by the server on each visit to the Website. The term "cookies" is used broadly in this context to include similar tracking technologies that can store information on your computer. The term "computer" refers to any terminal device you use to access the Website, such as your personal computer, tablet, or mobile phone.

2. Which Law is applyed?

Cookies are governed by the "e-Privacy" Directive 2002/58/EC, as amended by Directive 2009/136/EC (which has been incorporated into Greek Law by Law 3471/2006), and explicitly provided for in Regulation 2016/679 on the Protection of Personal Data, recital 173. According to applicable law, "The installation of cookies is allowed only with the user's consent and after appropriate information has been provided to the user."

For this reason, during the user's first visit to the Website, pop-up windows appear where you can express your consent to the installation of cookies.

3. Are Cookies Installed Without the User's Prior Consent?

There are "cookies" that have been deemed as technical-functional and necessary for the connection to websites or for the provision of internet services (see also term 6 below). <u>For these cookies</u>, prior consent is not required by law.

We distinguish the following categories:

 Cookies that are necessary for the recognition or preservation of content entered by the subscriber or user during a session on a website throughout the duration of that session. (For example, such cookies are necessary when the user fills out an electronic

- form). The same category includes "persistent" cookies installed for the same purpose and last for a few hours.
- Cookies that are necessary for the authentication of the subscriber or user in services that require authentication.
- Cookies installed for the security of the subscriber or user, such as cookies that detect repeated unsuccessful login attempts or improper use of authentication mechanisms.
- Cookies with multimedia content, such as flash player cookies, during a session on a
 website. Such cookies are, for example, cookies that are set when viewing a video on
 the website visited by the user.
- Cookies that are necessary to perform the technique of load balancing during a connection to a website.
- Cookies that "remember" the subscriber's or user's choices regarding the presentation
 of the website (e.g. cookies concerning the choice of language or the presentation of
 search results on a website).
- Cookies that are installed through plug-ins on social networking sites and are used to share content between authenticated members who have already logged in.

4. Why do we use them?

We use cookies on the website for the following purposes: (a) to facilitate your navigation, (b) to analyze the usage of our website, and (c) to assist us through marketing actions.

We use two categories of cookies:

- Temporary cookies (session cookies) which are deleted when the user closes their browser.
- **Permanent cookies (persistent cookies)** which remain on the user's computer for a specified period (minutes, days, or years).

5. What kind of information is stored in the cookie?

The information stored on your computer through cookies may be related to web pages you have visited from your computer, advertisements you have clicked on, the type of browser you are using, your IP address, your location, the language you have selected, and the date and time you visited the website. Therefore, cookies may collect personal data. When we use cookies that collect personal data, the collection is covered by the Privacy and Personal Data Processing Policy of our website, which you can find in the Privacy and Data Protection Policy (www.genlab.gr/privacy).

The functionality of the website will not be significantly affected if you disable or do not accept the use of cookies on this website. However, this may result in difficulties navigating the website, and certain features may not be available.
